NEW BUSINESS

- 1. PUBLIC HEARING: CITY PLAN FOR EXPENDITURE OF CDBG FUNDS IN CONJUNCTION WITH THE BARLOW SEWER PROJECT.** Mayor Lansford request a motion and second to open the public hearing.

MOTION: Brozak made a motion to open the public hearing; seconded by Scarbeary.

- 3. RESOLUTION 2017-12. AUTHORIZING AND APPROVING THE EXECUTION OF A PURCHASE CONTRACT FOR REAL PROPERTY WITHIN THE CITY OF STREATOR, ILLINOIS, A PORTION OF THE KEEN SERVICE PROPERTY, COMMONLY KNOWN AS 201 WEST BROADWAY STREET, IN BRUCE TOWNSHIP.**

Mayor Lansford requested a motion and second to authorize and approve the execution of a contract for property between the City of Streator and the Estate of Shirley Keen at 201 West Broadway St.

MOTION: Crouch made a motion to execute a purchase agreement for property at 201 W. Broadway Street for an alternative location for Hardscrabble Park; seconded by Brozak.
