

ORDINANCE 2018-13

AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT
BETWEEN THE CITY OF STREATOR, ILLINOIS AND MARY LIN J. MEYERS
TRUST & IVA L. CAMERON REVOCABLE TRUST

WHEREAS, Mary Lin J. Meyers Trust & Iva L. Cameron Revocable Trust are the owners of property comprising approximately 37 acres in the Southwest Quarter of the Southeast Quarter of Section 30, Otter Creek Township, LaSalle County, Streator, Illinois; and

WHEREAS, the City of Streator desires to annex said property, as it is contiguous to the City of Streator; and

WHEREAS, the City of Streator has authority pursuant to Chapter 65 ILCS 5/11-15.1 Annexation Agreements to enter into annexation agreements; and

WHEREAS, the City of Streator has given notice and conducted a public hearing of this proposed agreement in the manner required by law.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Streator, Counties of LaSalle and Livingston, Illinois as follows:


Section 1: That the City of Streator has found it is in the best interest of the health, safety, and welfare of the citizens of the City of Streator that the mayor be authorized to enter into an annexation agreement with Mary Lin J. Myers Trust & Iva L. Cameron Revocable Trust, owners of property legally described as the Southwest Quarter of the Southeast Quarter of Section 30; excluding the 3 acres owned by the First Christian Church of the Nazarene, in Otter Creek Township, City of Streator, LaSalle County, Illinois comprising of 37 acres, more or less, to make it consistent with surrounding property uses, be and the same is hereby approved.

Section 2: That the annexation agreement between the City of Streator and Mary Lin J. Meyers Trust & Iva L. Cameron Revocable Trust, owners, of property comprising approximately 37 acres of land in the Southwest Quarter of the Southeast Quarter of Section 30, Otter Creek Township, LaSalle County, Streator, Illinois, is attached hereto as Exhibit "A" on behalf of the City of Streator.

Section 3. The Mayor and city clerk of the City of Streator are hereby instructed and authorized to sign the document attached as Exhibit "A" on behalf of the city of Streator.
