ORDINANCE 2018-14

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF STREATOR, ILLINOIS, COUNTIES OF LA SALLE AND LIVINGSTON, OUTSIDE THE CITY LIMITS, FOR THE JOHNSON PROPERTY LOCATED WEST OF THE VERMILLION RIVER

WHEREAS, a written petition (attached as Exhibit A) signed by the legal owner of record of all land within the territory hereinafter described, has been filed with the Clerk of the City of Streator, county of LaSalle, Illinois, requesting that said territory, legally described as that part of the South 35 acres of the West 90 acres, lying West of the Vermillion River in the Southwest quarter of Section 23, Township 31, North, Range 3 East of the 3rd Principal Meridian, situated in Eagle Township, LaSalle County, Illinois; and

WHEREAS, the said territory is not within a fire protection district or a public library district; and the said territory does not include any highway under the jurisdiction of any Township; and

WHEREAS, the said property is owned by the City of Streator, Illinois; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statutes of the state of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-15.1.1; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the city of Streator; and

WHEREAS, it is in the best interests of the City of Streator that the territory be annexed thereto,

NOW, THEREFORE, be it ordained by the City Council of the City of Streator, County of LaSalle, Illinois as follows:

- Section 1: That the territory legally described AS LISTED ABOVE, Eagle Township, LaSalle County, and as indicated on an accurate map (attached as Exhibit B), which has been attached hereto and becomes a part hereof this ordinance, is hereby annexed to the City of Streator, LaSalle County, Illinois.
- Section 2: That the City Clerk is hereby directed to record with the LaSalle County Recorder and to file with the LaSalle County Clerk a certified copy of this ordinance, together with Exhibits A, and B which have been appended to the ordinance.
- Section 3: That this ordinance shall be in full force and effect from and after its passage approval, and publication in pamphlet form as provided by law.
