

ORDINANCE 2018-20

AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT
BETWEEN THE CITY OF STREATOR, ILLINOIS AND LARRY AND
MARLENE SAMPSON, OWNERS, A PARCEL LYING SOUTH ON ROUTE 18
EAST, SECTION 31, TOWNSHIP NORTH 31, LASALLE COUNTY, ILLINOIS

WHEREAS, Larry and Marlene Sampson, owners of property legally described as:

The South half of the Northwest Quarter of the Northeast Quarter of Section 31 North, Range 4 East of the Third Principal Meridian and the East 66 feet of the West 1120 feet of the North 660.5 feet of the Northwest Quarter of the Northeast Quarter of Section 31, Township 31 North, Range 4 East of the Third Principal Meridian all located in LaSalle County, IL; and

WHEREAS, the City of Streator desires to annex said property to the City of Streator; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the city of Streator; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statues of the of the state of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-151.1; and

WHEREAS, the City of Streator has given notice and conducted a public hearing of this proposed agreement in the manner required by law.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Streator, Counties of LaSalle and Livingston, Illinois as follows:

Section 1: That the City of Streator has found it is in the best interest of the health, safety, and welfare of the citizens of the City of Streator that the mayor be authorized to enter into an annexation agreement (attached hereto) with Larry and Marlene Sampson, owners of property legally described above in Township 31 North, City of Streator, LaSalle County, Illinois, to make it consistent with surrounding property uses, be and the same is hereby approved.

Section 2. The Mayor and city clerk of the City of Streator are hereby instructed and authorized to sign the document on behalf of the city of Streator.
