

ORDINANCE 2018 -27

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF STREATOR,
COUNTIES OF LIVINGSTON & LASALLE
Howard D. and Sharon S. Hedrick – 800 W. Second Street - 33-23-307-003

WHEREAS, a written petition (attached as Exhibit A) signed by the legal owners of record of all land within the territory hereinafter legally described as Part of the South 35 acres of the West 90 acres of the Southwest Quarter of Section 23, Township 31 North, Range 3 East of the Third Principal Meridian, described as follows: Commencing at a point 82 feet North and 25 feet West of the Southwest corner of Lot 9 in Block 6 in Orchard Addition located in the South Half of said Section 23; thence West along a line parallel to the North line of the South 35 acres of the West 90 acres of the Southwest Quarter of said Section 23, 950 feet, more or less, to its intersection with the middle line of the Vermillion River, thence along the middle line of said Vermillion River in a Northeasterly, Northerly and Northwesterly direction, following the meandering of said Vermillion River to its intersection with the North line of said South 35 acres of the West 90 acres of the Southwest Quarter of said Section 23; thence East 1070 feet, more or less, to the Northeast Corner of said South 35 acres of the West 90 acres of the Southwest Quarter of said Section 23; thence South 389.25 feet, more or less, to the place of beginning, except coal and minerals and the right to mine and remove the same; situated in LaSalle County, Illinois has been filed with the Clerk of the City of Streator, county of LaSalle, Illinois, requesting that said territory be annexed to the City of Streator; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the city of Streator; and

WHEREAS, legal notices regarding the intention of the city to annex said territory have been sent to all public bodies required to receive such notice by State statute; and,

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statutes of the state of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-15.1.1; and,

WHEREAS, it is in the best interests of the City of Streator that the territory be annexed thereto,

NOW, THEREFORE, be it ordained by the City Council of the City of Streator, County of LaSalle, Illinois as follows:

Section 1: That the territory legally described above and indicated on an accurate map (attached as Exhibit B), which has been attached hereto and becomes a part hereof this ordinance, is hereby annexed to the City of Streator, Counties of LaSalle and Livingston, Illinois.

Section 2: That the City Clerk is hereby directed to record with the LaSalle County Recorder and to file with the LaSalle County Clerk a certified copy of this ordinance, together with Exhibits A and B which have been appended to the ordinance.

Section 3: That this ordinance shall be in full force and effect from and after its passage approval, and publication in pamphlet form as provided by law.

Passed by the city council of the City of Streator, LaSalle and Livingston Counties, Illinois at a regular meeting thereof held on the 16th day of May 2018 and approved by me as Mayor on the same day.
