

ORDINANCE 2017-02

AMENDING THE MUNICIPAL CODE OF ORDINANCES OF THE CITY OF STREATOR,
LA SALLE AND LIVINGSTON COUNTIES, ILLINOIS, TITLE 3 "REVENUE AND
FINANCE", CHAPTER 3.48 "FEES AND DEPOSITS FOR CITY SERVICES", SECTION
3.48.080 GOLFING FEES

WHEREAS, the Streator Municipal Code, Title 3, Chapter 3.48 establishes certain fees and deposits for City Services; and

WHEREAS, the City of Streator has found it necessary to amend Chapter 3.48, Section 3.48.080 Golfing Fees.

NOW THEREFORE, be it ordained by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois, as follows:

Section 1: The Streator Municipal Code Chapter 3.48 "Fees and Deposits for City Services" be and the same is hereby amended by deleting said Section and adding new Section 3.48.080 as follows, which Section shall supersede Ordinance 2014/15-38 adopted on April 27, 2015.

"Section 3.48.080 Golfing Fees

A. Unlimited Membership fees, which allows for the waiver of green fees during period from March 1st through December 31st. For the purpose of this section:

- "single" means a anyone 19 years of age or older.
- "couple", means a husband and wife, father or mother and daughter/son, same sex and heterosexual partners
- "Family" means a husband and wife and/or father or mother with children ages 6 to 18 years old. Also includes same sex and heterosexual partners with children.
- "Junior" means individual students ages 12 through 18 years old.

All unlimited season passes are to be used by purchaser *only*.

Section 2: Each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance nor any part thereof, other than that part affected by such decision.

Section 3: That except as to the amendments heretofore mentioned, all chapters and articles and sections of the Streator Municipal Code shall remain in full force and effect.

Section 4: This ordinance shall be published in pamphlet form and shall take effect immediately upon publication and shall be incorporated into the Streator Municipal Code.


