

ORDINANCE 2018-36

AMENDING TITLE 10, CHAPTER 10.24, "STOPPING STANDING AND PARKING" OF THE STREATOR MUNICIPAL CODE OF ORDINANCES, LA SALLE AND LIVINGSTON COUNTIES, ILLINOIS BY DESIGNATING NO PARKING ZONES (On the North Side of the 400-600 blocks of West Bluff Street beginning at Van Buren Street to Lowden Road)

WHEREAS, the *Municipal Code of Ordinances of the City of Streator, LaSalle and Livingston Counties, Illinois*, regulates motor vehicles and traffic; and

WHEREAS, Chapter 10, Section 10.24 of the *Municipal Code of Ordinances of the City of Streator, Illinois* has been previously amended for the purpose of, more specifically, regulating motor vehicles and traffic within the City of Streator, LaSalle and Livingston Counties; and

WHEREAS, the Illinois Vehicle Code, *Illinois Compiled Statutes 625 5/11-708* allows local authorities after appropriate study to determine when warranted to designate the installation of "no parking"; and

WHEREAS, the City of Streator, acting by and through its City Council finds that it is in the best interest of the public health, safety and welfare to establish certain streets as "No Parking" pursuant to one or more of the established warrants for said streets contained in the Uniform Manual on Traffic Control Devices of the Illinois Department of Transportation.

NOW THEREFORE, be it ordained by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois, as follows:

Section 1: That the *Streator Municipal Code of Ordinances*, Chapter 10, Section 10.24 "Stopping, Standing, and Parking", be and the same is hereby amended by adding the following be designated a "No Parking Area" at the following location:

NO PARKING:

- **On the North Side of the 400-600 blocks of West Bluff Street beginning at Van Buren Street to Lowden Road**


Section 2: That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance nor any part thereof, other than that part affected by such decision.

Section 3: That except as to the amendments heretofore mentioned, all chapters and articles and sections of the Streator Municipal Code of Ordinances, Counties of LaSalle and Livingston, Illinois, shall remain in full force and effect.

Section 4: That this ordinance shall be published in pamphlet form and shall take effect ten (10) days following publication and shall be incorporated into the *Code of Ordinances of the City of Streator*.
