PROCEEDINGS OF THE STREATOR CITY COUNCIL **SPECIAL** MEETING OF **NOVEMBER 29**, **2016** HELD AT THE TEMPORARY CITY ADMINISTRATION LOCATION OF #15 NORTHPOINT DRIVE AT **7:00 P.M.**

CALL TO ORDER: Mayor Lansford presiding.

1. PRESENTATION OF NORTHPOINT PLAZA DEVELOPMENT PLANS

Scot Wrighton, City Manager, briefed Council on the reason for the meeting, reading a press release regarding Big R Stores agreement with Northpoint Development Holdings for bringing a store to Northpoint Plaza. Wrighton stated that the \$2,500,000 in GO bonds was waiting until confirmation of the development. Keith Weinstein, Northpoint Development Holdings stated he was expecting more stores to locate in the plaza and gave an overview of the improvements he was proposing to make at the center.

3. ORDINANCE 2016-39. AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF NOT TO EXCEED \$1,700,000 GENERAL OBLIGATION REFUNDING BONDS (ALTERNATE REVENUE SOURCE), SERIES 2016A, OF THE CITY OF STREATOR, LASALLE AND LIVINGSTON COUNTIES, ILLINOIS, FOR THE PURPOSE OF REFUNDING CERTAIN OUTSTANDING ALTERNATE BONDS OF SAID CITY, PROVIDING FOR THE PLEDGE OF CERTAIN SALES TAXES TO THE PAYMENT OF THE PRINCIPAL AND INTEREST ON SAID BONDS AND THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPAL AND INTEREST ON SAID BONDS IF SAID PLEDGED REVENUES ARE INSUFFICIENT TO MAKE SUCH PAYMENT, AUTHORIZING THE SALE OF SAID BONDS TO ROBERT W. BAIRD & CO. INCORPORATED, AND DIRECTING THE EXECUTION OF AN ESCROW LETTER AGREEMENT IN CONNECTION WITH THE ISSUANCE OF SAID BONDS..

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUE OF NOT TO EXCEED \$2,500,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2016B, OF THE CITY OF STREATOR, LASALLE AND LIVINGSTON COUNTIES, ILLINOIS, FOR THE PURPOSE OF PAYING THE COSTS OF ELIGIBLE REDEVELOPMENT PROJECTS WITHIN THE CITY'S NORTHPOINT TIF DISTRICT REDEVELOPMENT PROJECT AREA, PROVIDING FOR THE PLEDGE OF CERTAIN TIF REVENUES TO THE PAYMENT OF PRINCIPAL AND INTEREST ON THE BONDS AND THE LEVY OF A DIRECT ANNUAL TAX TO PAY SUCH PRINCIPAL AND INTEREST IF THE PLEDGED REVENUES ARE INSUFFICIENT TO MAKE SUCH PAYMENT, AND AUTHORIZING THE SALE OF SAID BONDS TO ROBERT W. BAIRD & CO. INCORPORATED.
