

ORDINANCE 2016-01

AMENDING TITLE 10, CHAPTER 10.24 OF THE MUNICIPAL CODE OF ORDINANCES OF THE CITY OF STREATOR, LA SALLE AND LIVINGSTON COUNTIES, ILLINOIS BY DESIGNATING THE ADDITION OF ONE STOP SIGN ON NORTH SHABBONA WHERE IT INTERSECTS WITH FOURTH STREET

WHEREAS, Chapter 10, Section 10.24 of the *Streator Municipal Code* has previously been amended for the purpose of, more specifically, regulating motor vehicles and traffic within the City of Streator, LaSalle and Livingston Counties; and

WHEREAS, Streator Dependable submitted a request to the City requesting the addition of a stop sign at the northeast corner of the intersection North Shabbona and Fourth Streets just prior to the entrance of the Streator Dependable; and

WHEREAS, based on the fact that the traffic counts warrant 4-way control, staff has recommended that the intersection become a 4-Way Stop intersection; and

WHEREAS, the City of Streator, acting by and through its City Council finds that the general safety of the public would be best served with the addition the stop sign on the northeast corner of the intersection of North Shabbona and Fourth Streets just prior to the entrance of Streator Dependable.

NOW THEREFORE, be it ordained by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois, as follows:

Section 1: That the *Streator Municipal Code*, Chapter 10, and Section 10.24 “Stopping, Standing, and Parking, be and the same is hereby amended by adding the following a stop sign at the following intersection:

➤ **On the northeast corner of northbound Shabbona Street where it intersects with Fourth Streets (as seen Exhibit A)**

Section 2: That appropriate signage and pavement markings be installed as seen on the attached Exhibit A, which has been attached hereto and becomes part hereof this ordinance and in conformance with the Manual on Uniform Traffic Control Devices.

Section 3: That this ordinance shall be published in pamphlet form and shall take effect ten (10) days following publication and shall be incorporated into the *Streator Municipal Code of Ordinances*.
