

ORDINANCE 2016-09

APPROVING A CHANGE TO THE ROADWAY NAME DESIGNATIONS OF THREE PLATTED STREETS (WESLEY STREET, CENTER STREET, AND EDSON STREET) IN THE CITY OF STREATOR LOCATED IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 35, TOWNSHIP 31 NORTH, RANGE 3 EAST OF THE THIRD PRINCIPAL MERIDIAN, LASALLE COUNTY, ILLINOIS

WHEREAS, the City of Streator, acting by and through its City Council is desirous of amending existing street name designations depicted on previously recorded plats of subdivision to change the roadway names of three platted streets within the City; and

WHEREAS, it has been found that the change of designation will not affect any existing property addresses; and


WHEREAS, the city of Streator has determined that it is advisable for the health and welfare for the city to officially name all streets.

NOW THEREFORE, be it ordained by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois as follows:

- Section 1: That a Street Name Designation Change Exhibit detailing the proposed name changes and limits of the proposed changes in the form and content of Exhibit "A" is attached hereto and made a part hereof be and same approved.
- Section 2: That this ordinance shall be published in pamphlet form and be in full force and become effective immediately after its passage as provided by law.
- Section 3: That the City Clerk shall cause a copy of this ordinance along with Exhibit "A" to be filed with the County of LaSalle as provided for by law.

Passed by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois at a regular meeting thereof held on the 20th day of July 2016, and approved by me as Mayor on the same day.

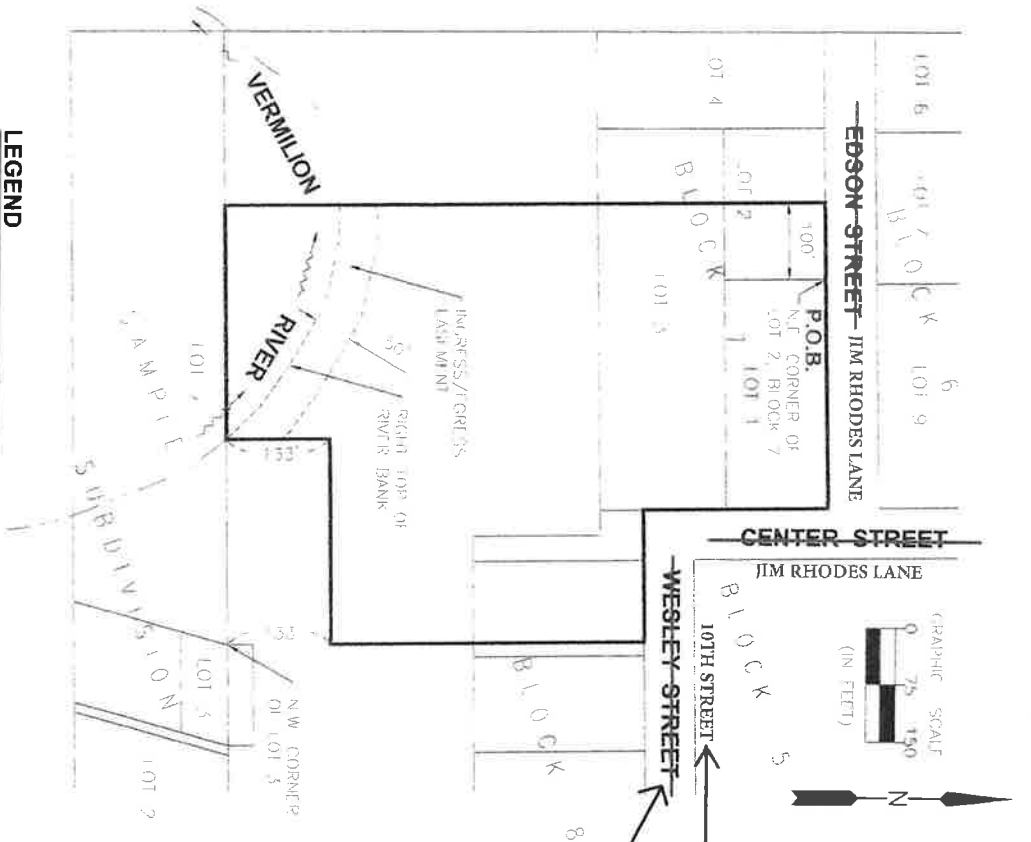

Roadway Name Change Descriptions

1. The platted road right-of-way designated as Wesley Street in Moore and Plumb's Addition to the City of Streator and Wood's Addition to the City of Streator shall be changed to 10th Street within the following limits:

From Wesley Street's intersection with the west right-of-way of Center Street at the eastern line of Blocks 10 and 13 of Moore and Plumb's Addition to the City of Streator to its intersection with the east right-of-way line of the platted Center Street located in Wood's Addition to the City of Streator

2. The platted road right-of-way designated as Center Street in Wood's Addition to the City of Streator shall be changed to Jim Rhodes Lane

3. The platted road right-of-way designated as Edson Street in Wood's Addition to the City of Streator shall be changed to Jim Rhodes Lane
